Mailing Labels

Conditions for Use of Mailing Labels

The following conditions are stipulated and must be agreed to in writing by the person or organization wishing to use the list:

1. The contents of all materials to be included in the proposed mailing to the membership must be submitted with the mailing label request and approved by the Executive Director. Only approved materials may be included in the mailing.
2. There may be no reference to the DPTA or the APTA made in the mailing materials.
3. The list will be provided electronically in CSV or Excel Format. Users of the labels must agree not to copy or otherwise duplicate the list of names and addresses or the set of the labels in whole or in part, as the list is intended for a one-time use only. Users may request additional mailing labels in exchange for an additional fee.

Cost of labels is **\$100.00**.

Labels will be emailed within 5 - 7 days after receipt of the mailing label request form along with your check or credit card payment, and approval of the literature you plan to mail.
